SUBJECT OF THE AGREEMENT

The Bank shall be responsible for the account opening, acceptance and deposit of funds into the Account, transfer and withdrawals of funds from the Account, and the execution of other operations as per the Account Holder's instructions subject to the Bank's charter, policy and procedures and other founding documents.

1. ACCOUNT OPENING AND OPERATIONS

On the basis of a completed Application Form and Supporting documentation, the Bank shall open the account and thereon operate it on behalf of the Account Holder.

Cash withdrawals and money transfer instructions shall be executed by the Bank only on the basis of original written instructions or electronic payment orders received from the Account Holder.
All operations shall be conducted within the limits of the available balance on the Account.

Exceptions to the required minimum balance may only occur when the Bank charges fees for the Account Holder.

In cases where the Available Balance is insufficient to cover all the withdrawals or payment instructions, the Bank will follow the order of priority as stipulated by the Account Holder.

The Account Holder agrees to pay for all related account fees according to the Bank's current List of Tariffs.

2. RIGHTS AND OBLIGATIONS

2.1 Rights and Liabilities of the Bank:

2.1.1. The Bank guarantees that information regarding the Account Holder, and any Account operations will remain confidential to the extent permitted by law.

2.1.2. The Bank reserves the right to amend the tariffs without prior notification to the Account Holder.

2.1.3. The Bank reserves the right to deny any applicant and/ or terminate the Account should it be found at any time that the Account Holder is involved directly or indirectly in any activity deemed illegal under host country laws/ regulations, internal sanction lists or international conventions and agreements as may be updated from time to time.

2.2 Rights and Liabilities of the Account Holder:

2.2.1. The Customer has the right to give instructions on the account except as otherwise provided by the Law and subject to the Bank's Policies and Conditions.

2.2.2. If given cheque books, the Account Holder shall keep his/her cheque books safe and is required to immediately report in case of loss of any leaves.

2.2.3. If applicable, the Account Holder is entitled to receive interests on the account until closure of the account.

3. TERMS OF VALIDITY

3.1. The Agreement shall be effective from the date of its signature by both Parties.

3.2. The Account Holder can terminate the Agreement at any time on the basis of a written application to close the Account, resulting in account closure.

3.3. The Bank has the right to terminate this agreement if the account is considered dormant for a period of 12 months or more or for any other reason that the bank deems necessary in accordance with the rules set by the Bank of Zambia.

3.4. If the Agreement is terminated, credit funds on the Account shall be returned to the Account Holder or, upon the Account Holder's instructions shall be transferred to another account within a reasonable time.

3.5. The agreement is subject to the terms and conditions as found on www.abbank.co.zm and may be changed from time to time at Bank's discretion.

4. FINAL PROVISIONS

4.1. Disputes which cannot be settled on a bilateral basis will be resolved in the courts of Zambia and subject to the Laws of Zambia.

4.2. The Account Holder hereby acknowledges that he/she has read, understood and agreed to the provisions of the contract.
